

MAYOR'S COLUMN

May Council Meeting Outcomes:

Thank you:

Councillors recorded a thank you to staff for ensuring the two flag poles were in place at the Memorial Wall at the Flinders Arts and Entertainment Centre to enable the Australian and New Zealand flags to be flown for the Anzac Day March.

Dog Registration Fees:

The applicable fees for the 2018-19 year were approved to be unchanged from those applied this year. Once again there is a substantial discount for registrations paid prior to 30 June 2018 for the 2018-19 year.

Planning Permits:

Advice was received on the wording required for the addition of "Notes" to the permits. Council noted the provided wording to be included in permits to clarify that the notes included on the permit do not form a part of the permit but are added to assist the applicant to recognise that legislation other than that relating to planning is relevant to the development. An example is that for a dwelling, once planning approval is given, building and plumbing permits will be required to complete the project.

Solid Waste Management

Council received and noted the report from staff of the actions carried out so far in the process of bringing Council's solid waste management on Flinders up to standards required by the Environmental Protection Authority (EPA). Failure to do so could result in hefty fines.

The report is a detailed summation of the Council's progress to date and effectively consolidates numerous briefings that have been provided to councillors over a considerable period of time. Council staff are in the process of costing the works on the basis that the scope of waste services previously identified through an external contractor involvement process will be carried out in-house. Unfortunately, the previous external contractor identified was purchased by a larger company and there amended costs did not provide the result that Council was looking for.

The major cost involved is in the handling of putrescible waste and Council must develop

a burial system that has a cell with a very expensive lining and collect and monitor resulting leachate. The less waste going into the cell, the lower the ongoing replacement costs of the cell. Putrescible waste will be baled and stacked in the cell to keep the volume being buried to a minimum.

The ongoing cost of the cell can be reduced by separating as much and as many recyclable/reusable goods out of household waste as possible. The most efficient way to do this is separation at the source, at the home. Council staff are currently costing the implementation of a wheelie bin collection service that would encourage and assist this separation process. A report on costs of implementation of the cell and the collection service will be presented to Council in the near future for consideration and to assist in making the decision on next steps.

Whitemark Gym Trial

The trial period for the operation of the gym is coming close to its end. A report on usage from the Whitemark Gym Committee outlined high usage and strong support for the gym. Council will receive a detailed report for discussion at the June workshop and consideration at the June Council meeting.

Northern Tasmanian Development Corporation:

Council received its quarterly report on the actions of the NTDC of which it is a shareholder.

Flinders Business Economic Social Structural Review:

Council has attained a \$52,000 grant from the Building Better Regions Fund to undertake this study that is aimed at giving some definition to the cost of doing business on Flinders Island as compared to the mainland. The resulting information will be available to support lobbying and grant applications in the future. Council approved a budget amendment to enable the project to begin this financial year.

Community Grants and Gunn Bequest:

Council approved \$4,110 worth of community grants spread across the following community organisations:

Flinders Island Show Society; Flinders Island Sub Branch of the RSL; Friends of the Bass Strait Islands and the Flinders Island Sports and RSL Club.

The Gunn Bequest, allocated annually, is 50% of the annual interest accruing on the bequest left with Council for this purpose by Jack and Enid Gunn. \$1,610 was allocated between the Flinders Island Women's Golf Club and Flinders Island Bowls Club.

- Physical Locality Staffing Policy, once it has been incorporated into the Recruitment Policy.

Closed Council:

In the closed session Council discussed and approved the KPIs to be used for the General Manager's 2018 Performance Review.

All councillor positions, seven for Flinders, will become vacant to be refilled by newly elected members for a term of four years.

Who can vote at a local government election?

Anyone who is enrolled on the State Electoral Roll for an address in a municipal area, is automatically enrolled for the Flinders municipal area as well.

Other people who own or occupy land in the Flinders municipal area, or are the nominated representatives of a corporate body which owns or occupies land in the municipal area, are also eligible to enroll, **but must apply to be added to the General Manager's roll**. Application forms are available from Council's front office.

Flinders Business Economic and Social Structural Review

Public Meetings 30th May 10am and 5.30pm

Due to its unique nature, Flinders Council considers that Flinders Island does not attract sufficient levels of Tasmanian and Australian Government funding to adequately respond to the challenges created by our remote island location including in everyday life, running a business and in delivering public and community services.

With federal funding assistance through the Building Better Regions Program, Council has engaged FTI Consulting to undertake a review that will deliver an evidence base to inform government decisions and better assist in attracting appropriate levels of funding into the future.

To ensure the review reflects the real lived experiences of Flinders Island residents and visitors, a community survey will be conducted to generate the data needed to highlight the challenges faced by Flinders Island, such as the high costs of key goods and services and the Island's reliance on community volunteers.

It is critical to the review's success that all Flinders Islanders have an opportunity for early input on its direction, therefore **two community meetings will be held on 30 May 2018, at 10am and 5.30pm at the FAEC.**

At the meetings, those interested in contributing to the project, for example in developing the survey questions, will be given further information on the variety of ways that they can do so.
