5.1 Chris to update Committee on progress of procurement for Whitemark jetty.

At the last meeting it was stated that Council was waiting on Mick to return to the Island to undertake the repair work. Richard confirmed the floatation device has arrived, the pole post and box that it sits in has been ordered and Council need to arrange to bolt in place once arrived. Council has arranged for this to occur next week.

Richard Harley will check with Mick Sherrif regarding the remainder of procurement items.

#### 6. RAMP INSPECTION UPDATE

Justin Nicholls and Andrew Donnellan to report to the committee on the audit of maintenance requirements of the boat ramps inspected on 16 June 2023.

#### 7. CONCEPT PLAN

An update was provided by Dennis Cooper to the committee regarding the Concept Plan.

As per the Motion from the 1st of March 2023 Flinders Boating Special Committee meeting

"Moved: A Rae Seconded: J Holloway

The Committee endorses Dennis Cooper to develop a concept plan for a second smaller boat ramp on the north side of the Whitemark jetty, and to bring the concept plan back to the committee for consideration."

The committee requested draft concept plans be provided using initial drawings by Chris Wilson.

The drawings were received from the designer at 5:28pm pm on the day of the meeting and were unable to be circulated to members prior to the commencement of the meeting, they were presented during the meeting and displayed on screen.

Members discussed the drawings and addressed the queries in the email from the designer which were:

- 1. Need to know if you are going to pour this on site considering how far the water goes out we could get this done or making panels to put in?
  - Committee members noted the pour will be in one place.
- 2. I don't think there was a specific discussion about the length. I have made slightly longer than the existing but from photo's I have seen making a ramp for low tide does not seem feasible as the beach seems flat at low tide and could not launch a boat anyway? I have made it 1.5m longer than existing.
  - Committee members noted the ramp should be four (4) metres shorter than the existing ramp on the other side and have a three (3) metre flat apron at the end.
- 3. From the previous drawings and the survey there is a bit of a discrepancy about the high tide mark. Previous design seems to indicate a high tide line 600mm higher than the survey appears to indicate. This isn't really a problem as it is what it is but just wanted to make you aware. The high tide line shown on the drawings is between the 2.
  - The high tide mark varies, committee members did not have a problem with this.

Modifications to the drawings are required, the drawings are to be taken to site and checked, Richard Harley will meet members at 11am on Thursday 7/9/2023 to address the queries and amend the drawings.

## 8. OTHER BUSINESS:

The committee would like to have a financial report provided at the next meeting.

The price of the lifesaving ring was requested by Dennis Cooper.

Richard Harley confirmed he knows where the lifesaving ring is to be fitted.
