#### INTRODUCTION

Section 82 of the *Local Government Act 1993* (the Act) requires the General Manager to prepare budget estimates of the Council's revenue and expenditure for each financial year which include the estimated revenue, expenditure, borrowings and capital works plus other details required by the Minister.

The Current 2023/24 budget has provision for the purchase of a steel drum roller to be added to the fleet. This roller is intended for use in the road re-sheet program commencing October 2023.

Since looking to purchase the budgeted steel drum roller it was identified that a more suitable machine is available. The cost of the most suitable machine is greater than the sum of \$140,000 budgeted CAP2223-14.

Details of the machine identified are:

- Caterpillar CS68B,
- built in August 2021,
- approximately 900 hours of machine time, and
- available for purchase now.

This type of machine is very sought after by councils and contractors Australia wide.

Due to the scarcity of low hour steel drum rollers, we must secure the machine listed above which is currently priced at \$189,000.

#### OFFICER'S REPORT

Council currently utilises a multi-tyre roller to compact road gravel. This method of compaction results in low density compaction and less desirable stability as well as a less than desirable frequency of pothole re-occurrence. The steel drum vibrating roller will reduce gravel road maintenance by producing a significantly improved pavement compaction standard and allow Council to prepare sections of roads to the standard required for sealing.

The lesser compaction rate of the current multi-tyre roller results in costly labor-intensive gravel road maintenance and poor public perception of Council roads. It is highly recommended that Council considers purchasing the more suitable machine. It is intended that this machine will be

actively involved with the up and coming road re-sheeting program to improve the quality of our gravel roads.

As the steel drum roller is of modern technology it may be attractive as an on Island hire option.

A capital budget variation of an increase of \$50,000 is therefore requested to enable the prompt purchase of the identified Caterpillar CS68B steel drum vibrating roller.
