# Mayor's Report

# **Quoin DA Decision**

As many in the community would be aware Council's recent decision to approve a Development Application for а tourist development on the Quoin property at Killiecrankie has been overturned by the state Resource Management and Planning Appeals Tribunal (RMPAT) following an appeal against Council's decision by a group of local residents. The appellant's challenged the decision on the basis that the Visually Sensitive Overlay that affects the site of the proposed development would be "compromised". Whilst many in our community are disappointed by the tribunal's decision, anyone, including the appellant's in this instance, are entitled to avail themselves of the opportunity to have Council's decision reviewed by the Tribunal. It is unfortunate that some in the community have chosen to vent their frustration at the tribunal's decision by targeting the appellants. If the tribunal had found the appeal without merit, they wouldn't have overturned Council's unanimous decision to approve the DA. The Flinders municipality is home to us all, as in any community there is a diverse cross section of people, with different views and opinions on a huge variety of matters . In instances such as this many have very passionate views depending on their perspective and beliefs. Name calling, abusive and threatening behaviour have no place in this "debate". As a community we are surely better and more mature than that.

#### The Future of our communities banking.

By now you would have received the community survey that has been commissioned by Bendigo Bank. To enable the bank to make an informed decision on the viability of establishing an agency in our community it is essential that everyone, every business and every community group complete the confidential survey and return it to Bendigo Bank in the reply paid envelopes supplied with the survey. In the survey it is important to highlight not only any savings you may have, but also any mortgages or loans, credit cards etc as all of these products are potential business for the bank and increase the possible viability of a local agency. Additional surveys are available at the following businesses ie Australia Post, Flinders Council, Walkers Supermarket, Bowman's shop, Killiecrankie Enterprises, Lady Barron store and F.I.A.A.I. Council will be sending a letter to absentee owners encouraging them to participate in securing a new banking provider. An email link to Bendigo Bank will be included as part of the information in the letter.

#### **State Road**

Council is aware that some of the sealing works on the State Main Road continues to see stones dislodged from the bitumen seal and this is creating a hazard to some motorists. The works were done by Council for the owner of the road the State Government. The State provided specifications of the size of stones to be used and the type of bitumen to use plus application rates for both. Council delivered the works to the specifications provided by the State Government. These specifications are very different to those used by Council on our roads which are not showing any signs of aggregate loss or risk to the motoring public.

Council has alerted the State to the problem and awaits direction as to how/if this problem will be fixed. Until that time motorists are requested to slow down when another vehicle approaches and to be aware of the hazard that is evident. Further sealing works may be required on these sections of road in the near future and Council apologises for any inconvenience the current situation is causing and any delays future works to rectify the problem may cause
