Visiting Podiatrist

I am very pleased to welcome Jennifer McManus as the new Flinders Island visiting Podiatrist. Jennifer will be working out of the new consulting room at the MPC, in the same building as the Medical Practice and Dental Surgery.

Jennifer has already made her first visit to the island and the teething issues arising during this time concerning the new consulting room have been rectified.

Bookings are made through the MPC Office.

Jennifer, otherwise works at the Foot Ankle & Rehabilitation Clinic in Riverside with Flinders Council administering the podiatry funding. This is made available through the Rural Primary Health Services Program which is now managed by Tasmania Medicare Local North.

Constitutional Recognition - Referendum Stalled

The announcement of an early election on 7 September has meant the referendum on the recognition of Local Government in the Constitution cannot legally be held with the election. Prior to the change of Prime Minister there had been a commitment from the Federal Government to hold the referendum in conjunction with the Federal Election.

Nomenclature Board of Tasmania -Advice of Gazette Notice Assigning and Altering Place Names

Under the Aboriginal and Dual Naming Policy it is proposed for Cape Barren Island to be Dual Named with the assignment of the Aboriginal name "truwana" to the island.

Also Road Route Codes changes are proposed for some of the roads on Flinders. For example, the Code B85 will apply to the Lady Barron to Palana Road and C801 will apply to the Emita to Memana Road. This will reflect more accurate details and descriptions for these roads.

RATES RESOLUTION 2013-2014

That in accordance with the provisions of the *Local Government Act 1993*, Council adopts the Rates and Charges for the period 1 July 2013 to 30 June 2014 in accordance with the resolutions which follow:-

1. General Rate:

- Government Act 1993, Council makes the following general rate on all rateable land (excluding land which is exempt pursuant to the provisions of Section 87) within the Municipal Area of Flinders for the period commencing 1 July 2013 and ending 30 June 2014, namely a rate of 8.951200 cents in the dollar on the assessed annual value of the land.
- 1.2 Pursuant to Section 90(4) of the *Local Government Act* 1993, Council sets a minimum amount payable in respect of the general rate of \$375.

2. Service Rates and Service Charges:

Pursuant to Sections 93, 93A, 94, 94A and 95 of the *Local Government Act 1993*, Council makes the following service rates and service charges on all rateable land within the Municipal Area of Flinders (including land which is otherwise exempt from rates pursuant to Section 87 but excluding Crown Land to which Council does not supply any of the following services) for the period commencing 1 July 2013 and ending on the 30 June 2014, namely:-

2.1 Waste Management:

Service charges for the making available of Waste Management Services to all land within the Municipal Area comprising waste disposal areas, waste transfer stations and related waste management facilities of \$140.

2.2 Fire Service Contribution:

Pursuant to Section 93A of the *Local Government Act 1993* Council makes the following service rates in respect of the Fire Service contributions it must collect under the *Fire Service Act 1979* for the rateable parcels of land within the Municipal Area as follows: -

Cents in the Dollar of AAV
General Land

0.332099

Pursuant to Section 93(3) of the *Local Government Act 1993* Council sets a minimum amount payable in respect of this service rate of \$36.

3. Separate Land:

3.1 For the purposes of these resolutions the rates and charges shall apply to each parcel of land which is shown as being separately valued in the valuation list prepared under the *Valuation of Land Act 2001*.

4. Adjusted Values:

4.1. For the purposes of each of these resolutions any reference to assessed annual value includes a reference to that value as adjusted pursuant to Section 89 of the *Local Government Act 1993*.

5. Installment Payment:

- **5.1** Pursuant to Section 124 of the *Local Government Act 1993*, Council:-
 - (a) Decides that all rates are payable by all ratepayers by two installments which must be of approximately equal amounts.
 - (b) Determines that the dates by which installments are to be paid shall be as follows: -
 - (i) The first installment on or before 22 October 2013; and
 - (ii) The second installment on or before 18 February 2014.
 - (c) Where a ratepayer fails to pay any installment within 21 days of the date on which the rates are due, the full amount owing becomes due and payable in accordance with Section 124 (5) of the *Local Government Act 1993*.

6. Discount:

Pursuant to Section 130 of the *Local Government Act 1993* Council offers to all of the ratepayers who are liable to pay rates and charges a discount of 2% if the rates and charges are paid by one payment on or before 22 October 2013.

7. Penalty and Interest:

- 7.1 Pursuant to Section 128 of the *Local Government Act* 1993, if any rate or installment is not paid on or before the date it falls due then: -
 - (a) There is payable a penalty of 10% of the unpaid rate or installment; and
 - (b) There is payable a daily interest charge of 0.025616 (9.35% per annum) in respect of the unpaid rate or installment for the period during which it is unpaid.

8. Words and Expressions:

Words and expressions used both in these resolutions and in the *Local Government Act* 1993 or the *Fire Service Act* 1979 have in these resolutions the same respective meanings as they have in those Acts.

1. Aboriginal Benefits Foundation

Grant Applications are considered by the board of the foundation at each directors meeting. The board currently meets approximately 6-8 times per year.

2. Tasmanian Community Fund: Grant Round 27

Grant Round 27 of the Tasmanian Community Fund will open on 24 August 2013. Applications for small grants (up to \$10,000) will close on 2 October 2013. Applications for medium grants (\$10,001 to \$90,000) will close on 16 October 2013. Round 27 Guidelines and application forms are not yet available but it's time to start thinking about your application.

3. The Small Grants for Small Rural Communities

The program will offer up to \$400,000 per round in grants up to \$5,000 for projects and activities that offer clear public benefit for communities, with populations of 10,000 or less, living in small rural and remote **Round 24 will open on 1st August 2013.** http://www.frrr.org.au
