#### MAYORS COLUMN

Tasmania Medicare Local (TMC) wants you to inform them about your health care needs through their latest **Health and Wellbeing Community Survey**. The survey is designed to add to TMC's understanding of access to community-based health care services and health-related needs outside the hospital system. The survey includes questions about how people rate their health; lifestyle factors that may affect their health; and availability of local health, transport and other services.

Tasmanians aged 15 years and over are urged to respond.

TMC says the information gathered will guide the work they are doing to identify local health care needs, address any service gaps and make it easier for Tasmanians to access the health services they need closer to home.

Funding for programs such as Podiatrist visits, and the Community Nurse is now allocated by the TMC. By filling in the survey you can comment on issues that are specific to the island, such as PTAS. This will assist Council, Community Officer and the Health Committee in lobbying for and achieving better primary health support for all islanders.

Survey closes 29<sup>th</sup> September.

This is part of the Council's plan to provide and plan for assets that are maintained at the best possible standard within Council's means.

The tour included viewing the newly developed access to Marshall Bay at Castle Rock. This is now a public access acquired by Council during a subdivision of surrounding land, for the benefit of current and future generations.

Council has an abundance of facilities for a population of 800 and the challenge for Councillors is to identify the infrastructure that will benefit current and future community members, whilst also being affordable within the Council Budget.

Flinders Councillors are once again frustrated that the State Government is favoring King Island with a subsidy of \$30 per head for cattle shipped off that island without even considering that Flinders producers may have the same issues. This appears to be a repeat of the disdain that the government treated the island with when the then Premier, David Bartlett announced funding for renewable energy for Flinders at an island event and then proceeded to allocate all the funding to King Island. The General Manager has been proactive in contacting Brian Green's Office about the current inequality, Council will continue to seek a more equitable funding arrangement with the State Government.

# Introduction of New Approved Owner Builder Courses

Amendments to the *Building Act 2000* and the *Building Regulations 2004* have changed the requirements for prospective owner builders to gain registration from the Director of Building Control.

The amended owner builder legislation (28 November 2012) now requires prospective owner builders to undertake an approved owner builder training course or courses, prior to applying for registration. The Owner Builder Responsibilities Course must be completed within the 12 month period prior to the date of an application for registration.

The Director of Building Control previously approved the Owner Builder Kit (December 2012) as the interim approved Owner Builder Training Course, with the provision that approval of this Course be withdrawn once other Courses are approved by the Director.

Following a call for expressions of interest from training organisations and the subsequent approval process, three training organisations are authorised to deliver approved Owner Builder Training Courses for Tasmania.

This combination of training organisations will offer participants a variety of delivery modes being on-line, correspondence and face-to-face.

The new requirements were Gazetted on 31 July 2013 and are shown in the next column. They commence on 1 September 2013.

Note that evidence of completion of <u>both</u> categories of the courses is required to satisfy the eligibility requirements to be an owner builder.

Accordingly, the Owner Builder Kit (December 2012) will be withdrawn as the approved Owner Builder Training Course, effective 1<sup>st</sup> of September, 2013.

#### **BUILDING ACT 2000**

Section 30B(1)(g)

APPROVAL OF OWNER BUILDER TRAINING COURSES

PURSUANT to section 30B of the *Building Act 2000*, I approve the following owner builder training courses. All prospective owner builders\* must successfully complete a course from both Category A and Category B.

#### Category A: (Owner Builder Responsibilities)

An approved, Tasmanian owner builder course delivered by one of the following providers:

#### Category B: (Construction Industry OHS Induction)

Any Construction Induction Course delivered by a Registered Training Organisation containing the national training unit \*Work Safely in the Construction Industry' (CPCCOHS1001A).

These requirements commence on 1 September 2013 and supersede all previous advice in relation to approved owner builder training.

(\*If land is owned jointly, only one applicant for owner builder registration is to complete both required Owner Builder Training Courses.)

### Introduction of New Approved Owner Builder Courses continued.

Under the new work health and safety laws, which commenced in Tasmania on the 1<sup>st</sup> of January, 2013, there is a requirement for prospective owner builders to obtain their construction induction training by obtaining a 'White Card' from a Registered Training Organisation (RTO) that has the national training unit called 'Work Safely in the Construction Industry (CPCCOHS1001A) within their scope. It is not necessary to do both courses with the same training organisation. If an applicant has previously gained a 'White Card', that will suffice.

Once participants have evidence of successful completion of both requirements, they still need to apply for registration as an owner builder through their building surveyor. Applicants will be required to complete the approved Form 40 Application for Owner Builder Registration and provide their building surveyor with a copy of their training certificate and 'White Card'. In the event that there is more than one applicant for owner builder registration (i.e. more than one owner on the property title), only one applicant (the one who will be in charge on site) will be required to undertake the approved courses.

Building Surveyors', Architects' and Building Designers' co-operation in advising prospective owner builders of this new requirement is appreciated.

#### **GRANTS**

There are currently a variety of grants available that may be applicable to local community groups and organisations. Below are a list of the grants and their links for you to have a look at. If you have an idea or project we suggest you contact the funding body to discuss your eligibility and application.

### 1. Aboriginal Benefits Foundation www.aboriginal.org.au/grants

Grant Applications are considered by the board of the foundation at each directors meeting. The board currently meets approximately 6-8 times per year.

**2. Tasmanian Community Fund: Grant Round 27** Grant Round 27 of the Tasmanian Community Fund opened on 24 August 2013. Applications for small grants (up to \$10,000) will close on 2 October 2013. Applications for medium grants (\$10,001 to \$90,000) will close on 16 October 2013.

### 3. The Small Grants for Small Rural Communities - www.frrr.org.au

The program will offer up to \$400,000 per round in grants up to \$5,000 for projects and activities that offer clear public benefit for communities, with populations of 10,000 or less, living in small rural and remote areas.

### 4. First Home Owners Grant (FHOG) and First Home Builder Boost (FHBB) - www.sro.tas.gov.au

Applicants can receive \$7,000 for the FHOG for a new or established dwelling including a house, flat, unit, townhouse or apartment anywhere in Tasmania that meets local planning standards. The First Home Builder Boost (FHBB) provides an extra \$8,000 in addition to the FHOG.
