MEDIA RELEASE - CAPE BARREN ISLAND TELSTRA TOWER TO BE CONSTRUCTED

Flinders Council has successfully brokered negotiations with Telstra, the Aboriginal Land Council of Tasmania (ALCT) and the Building Better Regions Grant Funding (BBRF) body to ensure the final stage of the \$10.6 million Flinders and Cape Barren Islands Telecoms Transformation Project will be completed by June 2020.

The Telecoms Transformation Project was scheduled for completion in December

2019. By the end of June 2019, the four Flinders Island towers were complete on, with the final milestone of building the Cape Barren Island tower still outstanding. Acting General Manager, Heidi Marshall said, "That after working with our key stakeholders the BBRF, Telstra and ALCT, we identified a way forward to achieve the final completion stage. Flinders Council has agreed to invest an additional \$80k to achieve an outcome that is mutually beneficial to all parties." Mayor Annie Revie said, "Council is proud to make this commitment in recognition of the importance of completing this project."

This tower will not only benefit the community of Cape Barren Island/truwana but will complete the Telecoms upgrade for the whole of the Furneaux Group, from the northern areas of Palana and Killicrankie, to the southern areas of Lady Barron and Cape Barren. Mayor Revie said, "Without it, we would have missed a once in a lifetime opportunity, so we thank the BBRF, the Hon Minister Michael Ferguson (Minister of Science and Technology), Bridget Archer (Federal Member for Bass Tasmania) and Penny Finlay (Office of Aboriginal Affairs) for their support in facilitating progress towards achieving the final milestone."

The completion of this project is part of the Flinders Council's strategy to encourage people to live, work and invest on the islands, and improve livability for its residents. The Council is very keen and excited to see the final Tower built.

What Waste?

Council is commencing the segregation of waste at the Whitemark tip. The aim is to ensure that all waste that does not need to go into landfill is redirected.

Ultimately, our goal is to divert our waste to either recycling or other initiatives and so we need to start somewhere! It's a slow process, so please assist where you can and do keep an eye out for updates to our island's 'war on waste.'

Please segregate the following waste when coming to the tip:

1. Aluminium cans

The local school children are actively trying to divert aluminium cans from landfill. Hydro Tasmania and The Wharf Shed are both kindly donating 1c per can collected. To assist with this project, please ensure that **only aluminium cans** are placed in the reciprocals and are as free of liquid as possible. Aluminium can waste does NOT INCLUDE food tins. Drink cans only. No need to crush.

Deposit at School or the tip

2. Glass

All glass items can be deposited at the tip. The glass will be crushed and one day used in the waste disposal process as a covering material.

3. Cardboard

Cardboard is a biodegradable product that is best diverted to composting. For this reason we ask that boxes are flat, with the sticky tape removed before being deposited in the cardboard area at the tip.

Household Waste

Household waste is to be bagged tightly and disposed of in the bin provided.

The tip attendant will be happy to show you where to deposit what. Also remember the tip shop if you have anything that may be repurposed!

Parramatta Grass Trial

Around 12 months ago Council commenced a trial of roadside spraying to tackle Parramatta grass. Two areas were sprayed:

- Memana Rd The last 200m on the northern side before Lackrana Rd intersection. This section was chosen as it had been grazed and vegetation was short.
- Lackrana Rd— The first 1000m from the Memana Rd intersection both sides, to Trevor Nicholl's & Tim Wright's driveways. From Cameron's Inlet intersection travelling south, the first 200m on the western side ("Ben Werrin" driveway) and the first 600m on the eastern side (to Hydro Pole number 6319). In these areas the vegetation was all long.

The areas were treated with 2 litres of "Taskforce" and 150 litres of water per hectare in late February 2019. The trial will be ongoing as "Taskforce" stays in the soil for approximately 4 years and keeps killing the Parramatta grass as it tries to reestablish. However, after an inspection of the areas with Richard Mollineaux and agronomist Rob Winter, the trial looks very promising. There was an approximate 90% kill rate but this needs to be reviewed again in March 2020 and beyond. The treatment has also proven to be selective in that it is killing Parramatta grass whilst not affecting the other grasses in the plot areas. There does not yet seem to be much difference in the areas with short and long vegetation.

Policy Under Review

Council resolved at the 12 November 2019 Ordinary Council Meeting to adopt the **Furneaux Islands Festival Policy**.

The policy will lie on the table for public comment until 3 January 2020. It is available to download from the Council Website
