Lifter for Essendon

It is with pleasure that I can report that the Passenger Lifter for Essendon Airport has been ordered and will be delivered in the coming week or so.

I sincerely thank the Lions Club and the dedicated and hardworking members for taking on this project in such a driven manner. The grants they have raised, along with the amazing amount donated to the Lions for this project by you, the public, make the purchase of this lifter possible. At a cost of around \$21,000, over \$18,000 has been contributed through the Lions. Council has allocated funds to cover the smaller remaining cost.

So often in the Islands, to get the outcomes we all desire, we must work together to achieve them and this project is yet another wonderful example of the strength and support that exists within this Community.

This lifter will complete the trio of lifters already situated at the Launceston and Flinders terminals.

March Meeting decisions

Planning

Approved:

A Solar farm of up to 200kW and associated infrastructure including battery storage and switching gear to be installed around the power station at Thule Road.

A subdivision of 2 Lots in the Rural Zone at Harleys Road, Whitemark.

Refused:

A subdivision of 3 Lots in the Rural Zone within the Ecologically Sensitive and the Shorelines, Water Bodies and Watercourses Special Areas at West End.

Palana Speed Limit

The speed limit entering Palana will be reduced to 50 km/h in line with town speed limits in Tasmania.

The limit will be reduced to 20 km/h for the piece of road from the existing speed limit sign closest to the boat ramp to the boat ramp – a distance of approximately 0.7 km.

Whitemark Foreshore

Council adopted the Whitemark Foreshore Recreation Area Master Plan and approved the installation of a gas BBQ, shelter and picnic tables for this financial years works. The exercise equipment from the Healthy Islands Project will also be installed as a part of the Foreshore development. The new infrastructure will be installed in the area to the north of the boat ramp. The current shelter known as the Opera House will be dismantled due to safety issues.

Risk Management

Council adopted a Risk Management Framework and amended the Risk Management Policy. The Policy is open to public comment for 28 days and may be viewed at the Council offices or on Council's website

Other

The Employee Recruitment Policy that has been out for public comment was adopted. Flinders Council's commitment of three years of funding to Northern Tasmania Development (NTD), the regional body that assists in alliance of the eight northern Councils, together as a region, was confirmed.

Shipping

Chiller/Freezer Shipping Containers

The Shipping Committee has recommended that the containers be removed from service one at a time for maintenance. Furneaux Freight has indicated this could cause an issue with the transport of chilled and frozen goods.

The four containers are now three years old and one in particular has sustained damage during transit operations. To maintain the integrity of the containers, servicing and maintenance is necessary.

These four containers were purchased new, for the community, from the unexpended State Government Furneaux Shipping Contingency Fund in 2011, to mitigate the health and food quality issues that occurred with the transport of frozen and chilled goods in the old containers. The new containers are owned by Council and used by Furneaux Freight for the purpose of moving chilled and frozen goods in a safe manner to and from the Islands.

Matthew Flinders III

The Committee was also advised that with the "Matthew Flinders III" now back on the run the backlog of livestock to be shipped will be negligible by the time you read this.

Shipping Contingency Fund

The Committee has recommended that the unexpended State Government Shipping Contingency Funding for the 2012-13 and 2013-14 years be utilised to complete the concreting and hard paving of the heavy use areas of the port. The Committee recognises that the funds provided by the State Government can best be used to complete the works required in the port area to a high standard. Once Council ratifies recommendation, application will be made to DIER for the unexpended contingency funds to be allocated to Council for this purpose.

The Government Shipping Contingency Funding is an annual allocation made by the State to ensure the provision of a shipping service to the Islands. It is equivalent to the funds that used to be paid for a contracted shipping service to the When Furneaux Freight was Islands. established they chose not to enter into a formal contract with the State Government to provide the service to Flinders but do receive funding support to provide the monthly service to Cape Barren Island from the Contingency Fund. With the consistent service provided to Flinders by Furneaux the unexpended Contingency Funding, if not required to support a shipping crisis, is made available by the State Government to put towards projects that support the safe and efficient shipping of cargo between the Furneaux Group and mainland Tasmania. In the past this has been used to support the upgrade of the working port area and the purchase of the shipping containers used to transport the islands chilled and frozen food goods.

This year a portion of the fund has also been spent on an update of the 2010 Review on the Furneaux Shipping task. This study is currently being undertaken by DIER.

Membership

The Transport and Commerce representative positions are vacant and I encourage nominations for these positions. The Shipping Committee is the advisory committee to Council on Shipping and input from community sectors is important. I thank retiring members Michael Bowman and Mick Barrett for their input into the committee.

Community representation on the committee is through your Livestock, TFGA, Transport and Commerce representatives.

DIER and Tasports are also members of the committee.

Dogs

Council has had the displeasure of having to fine a dog owner for not controlling their dog.

The legislation requires that your dog is in your control (not just accompanying you) at all times when in a public space. Roaming dogs continue to be an issue on the island and all dog owners should be aware that Council is taking the matter seriously and will fine owners if dogs are found to be uncontrolled in a public area.

Dogs are not allowed inside any business premises or areas where food is being served, even if on a leash.

Your enjoyment of your dog should not be at someone else's expense or discomfort.

Littering at Public Disposal Receptacles

Our earlier plea for people to use the transfer bins at Killiecrankie and the Whitemark Tip responsibly, and in line with the signage posted next to the bins, continues to be ignored by some users. *Section 9* (listed below) of the Litter Act of Tasmania outlines the penalties Council can enforce for illegal use of these bins. If the transfer bins continue to be used for illegal dumping, Council will have no alternative but to impose the prescribed fines to recover the costs of waste removal that are currently being borne by all ratepayers.

Part 9 (2) (A to E) and (3) (A & B) are particularly relevant to Transfer Stations and litter bins supplied by Council for public use. I have provided these sections from the Act as excerpts below this notice.

Please note that a penalty unit is currently \$130.00.

As an example, the transfer bins at Killiecrankie were both completely filled by one inconsiderate person with an assortment of cardboard boxes, builders waste, concrete bags and plastic bins. The fine associated with this act could be some \$6500.

The staff time and cost was a huge impost on Council, not to mention the litter that accumulated around the bins from this thoughtless act. This will not be tolerated in the future and if caught, Council will impose the full fine possible.

Please only use the transfer bins for normal household waste.

9. Littering offences

(1) A person must not deposit litter in any public place except in a receptacle that the owner or controller of the public place has provided for litter.

Penalty:

Fine not exceeding -

(a) if the litter consists only of a single item of personal litter, 2 penalty units; or

- (b) if paragraph (a) of this penalty does not apply but the litter does not exceed 55 litres in volume, 20 penalty units; or
- (c) if the litter exceeds 55 litres in volume, 50 penalty units.
- (2) A person must not, in a public place, deposit litter in any receptacle provided for litter if it is, or reasonably ought to be, evident to the person that
 - (a) from markings on the receptacle or elsewhere at the public place, the receptacle is not a suitable receptacle for litter of that nature; or
 - (b) from the nature of the litter or receptacle, the receptacle is not a suitable receptacle for the litter; or
 - (c) the receptacle is already full; or
- (d) the receptacle has insufficient space, or remaining space, to hold the litter; or
 - (e) the receptacle is undergoing repairs or maintenance, is sealed or is otherwise temporarily unavailable for use as a receptacle for litter.

Penalty:

Fine not exceeding -

- (a) if the litter consists only of a single item of personal litter, 2 penalty units; or
 - (b) if paragraph (a) of this penalty does not apply but the litter does not exceed 55 litres in volume, 20 penalty units; or
- (c) if the litter exceeds 55 litres in volume, 50 penalty units.
- (3) A person must not, in a public place, deposit litter in any receptacle provided for litter if
 - (a) it is, or reasonably ought to be, evident to the person from the nature of the litter that the litter is of household or commercial origin; and (b) there are no markings on the receptacle to indicate that it is for
 - receptacle to indicate that it is for litter of household or commercial origin.

Penalty: Fine not exceeding –

- (a) if the litter does not exceed 55 litres in volume, 20 penalty units; or
- (b) if the litter exceeds 55 litres in volume, 50 penalty units.
