- Ring the Council office and let the receptionist know your details and the issue you are raising. If it is urgent, let that be known also.
- An alternative is to use the form on the Council website.
- Your issue will be given to the appropriate staff member and entered on a spreadsheet.
- Staff will notify you when your issue has been dealt with.
- If you have not had a response, ring to enquire.

Flinders Council Planning Scheme 2000 is the legal document regulating development in the Municipality. If are planning to develop your land or property, it must me the use and development standards of the Planning Schei

Each parcel of land has what is known as a "zone". Depend what "zone" your land is in determines what use and development standards you are required to meet. Zone n are available on Council's Planning Scheme webpage.
