Mayor's Column

Strategic Plan:

The Flinders Council draft Strategic Plan is now available for your feedback. The draft Strategic Plan outlines the areas that Councillors and staff believe are important for this Council to be active in to support our vision for the future, and to enable the legislative requirements imposed on Councils to be met. It outlines the direction that Council will take over the coming years, and in particular the next four years.

Annual work plans will be derived from the adopted Strategic Plan.

Councillors and staff need to know that the draft Strategic Plan also aligns with the aspirations of the Community and I encourage you to make your comment on this important document.

The Strategic Plan will be finalised post council receiving and considering your feedback and input.

Fees:

The general fees for 2015-16 year were set at the July Ordinary Meeting. As mooted previously there has been little change to charges overall with the major changes being in the planning and building sections. The list of fees and charges is available on the Website or upon request from the Council Office.

Rates:

Land values in the Municipality have increased and this is recognised by the Valuer-General in the property valuation

adjustment figures released in March this year. Council applies the adjustment figures for Assessed Annual Value, (AAV) to each property to calculate the rates payable. Since the adjustment factors were last applied to Flinders Council rates, the Valuer-General has deemed that the AAV of vacant residential land has increased by 10% and most other land classes including rural properties and non vacant residential has increased in value by 5%. Some commercial properties have seen no increase in the AAV due to adjustment factors.

The decision by Councillors at the July Ordinary Meeting was to let property values dictate the increase in rates receivable and thus make no change to the rate in the dollar of AAV charged.

In short, individual property rate increases will be due to an increase in the value of the AAV of the property as deemed by the Valuer-General.

The minimum rate is set at \$435 and applies to less than 35% of properties as per the legislative requirement.

The Waste Management Service Charge will rise by \$4 per property. The Fire Levy on the rates is collected on behalf of the State Government.

Rates will again be payable in two installments with a discount of 2% applicable to rates and charges paid in one payment on or before the 21st October 2015.

2015-16 Budget:

Council adopted the 2015-16 Budget Estimates at the July Ordinary Meeting. Income is budgeted at \$5.3 million and operating expenditure at \$5.7 million. The capital budget expenditure is set at \$1.125 million. The estimated operating deficit of \$410 thousand is one quarter of that estimated for the previous year and

included in the operating expenditure is a depreciation cost of \$1.47 million. Council has maintained estimated expenditure at 2014-15 levels and has an increased estimated income of \$1.1 million.

The biggest change in estimated income is from planned increased private works on the State Road and extra Roads to Recovery Funds announced by the Federal Government.

Rates, User Charges and Interest and Other Income makes up 59% of Council's income. The remainder comes from operating grants such as Federal Assistance Grants (FAGs), Roads to Recovery Funding and Capital Grants, such as the funding approved by the Tas Community Fund for the Lady Barron Fitness Annex that will compliment the hall improvements.

Councillors and staff are working hard to meet the Auditor-General's requirement to be targeting an operating budget surplus, whilst maintaining services and undertaking programs that encourage population growth, and maintain or improve infrastructure.

Telecommunications:

Council acknowledges and is deeply concerned about the limitations and issues that exist with the current telecommunications services on the Islands. Council also recognises these are an impediment to service provisions, population growth and economic activity on the Islands.

Council has engaged a company with specialist experience in the delivery of WiFi internet services and infrastructure to undertake a study that will consider the most effective way to bring sustained internet access to Flinders Island's black & grey spots.

Councillors also authorised the commissioning of a detailed feasibility study as a matter of urgency to support

overall telecommunications improvements to the Islands.

Councillors hope that the outcomes of these studies will provide the information required to leverage improvements and upgrades to the telecommunication and data coverage available on the Islands. We thank the State Government for providing the funding that has enabled these studies to be undertaken.

Other Council Activities:

Each quarter a full update of staff achievements against the Annual Plan is reported as an attachment to the Agenda. It is interesting reading to see just how much has been achieved. For instance, it reports that the Lughrata gravel quarry which was purchased in the 2014-15 financial year, now has a right of way established and the mining lease has been submitted to Mineral Resources Tasmania for approval. This asset will secure gravel supplies on the Island for many years to come and from the testing done will supply a very high grade of gravel to use on the road network.

A new bitumen sprayer truck and two automated aggregate spreader boxes have been ordered and will be available for the 2015-16 resealing program. Council has purchased these items under a loan with low interest set for 10 years. Interest earned on cash investments will be used to balance the interest expense and it is expected that in the longer term the interest income will exceed the interest expense on the loan.

When combined, these purchases show the investment Council continues to make into the delivery of core services, such as our roads, to the Community. The year ahead will see some major road sealing projects undertaken to improve the safety and lifespan of these important assets, which will utilise the increased funding

through the Roads to Recovery program and the funding provided by the State Government for upgrades to the Lady Barron Main Road.

Dog registration

All dog owners are reminded that the discount period to register dogs expires on 31 July. All dogs must be registered and microchipped to avoid infringement.

Dog owners are reminded that if your dog is not on your own property or under your effective control, it is “at large”. Council have received multiple complaints regarding this matter from those who feel that “roaming” dogs are effecting their enjoyment of the area. It is a fineable offence so please ensure your dog’s remain on your own property or on a lead when out.

Place of Assembly Licenses

The State Government (Public Health Services) have issued a revised public notice under s75A of the Public Health Act 1997, this specifies that the only class of places in respect of which a place of assembly licence is required is ‘Mass Outdoor Public Events’. The word ‘mass’ is defined as 1000 people or more, present for two hours or more.

Therefore Place of Assembly licences for buildings are no longer required and publically advertised events (where less than 1000 people will attend) are also no longer required.

Event organisers should be aware that their obligations as far as safety, emergency procedures and insurance remain.
