DESCRIPTION OF WORKS: Installation of security gate to control access into Port area.

Please Note: *Should the works identified in this permit proceed all conditions are deemed to be accepted by the permit holder.*

CONDITIONS OF PERMIT

- a) The works within the reservation are to be carried out such that at least one clear lane is open to traffic at all times. After hours, one lane in each direction shall be maintained. Traffic management shall be in accordance with DIER's General Specification G3 (available on the Department's web-site at <http://www.transport.tas.gov.au/road/specifications>) and the Department's "Traffic Control for Works on Roads - Tasmanian Guide 2011". The latter document is available on the Department's web site at http://www.transport.tas.gov.au/data/assets/pdf_file/0003/71868/Traffic_control_at_work_sites_-_Tasmanian_Guide_2011.pdf. Typical examples are shown in the relevant Australian Standard field guide. All traffic control must be performed and certified by accredited traffic control personnel. All works within the road reservation must also comply with relevant Occupational Health and Safety Regulations.
- b) The Department requires **seven (7) days notice** prior to any commencement of works within the State Road Reservation.

- c) Should the Department require the installation to be removed or altered to facilitate any future works, the cost of any such works shall be borne by the permit holder.
- d) At the time of installation and following completion of the works, the surrounding area must be left in a neat and tidy condition, with any spoil or excess materials to be removed from site.
- e) The permit holder will be responsible for any damage to road pavement, shoulder, verge, drainage and other structures that may occur during the work.
- f) The permit holder will be responsible for obtaining all necessary approval(s) from State Government agencies, Commonwealth Government agencies or Local Government for the works within the State Road Reservation including those relating to environmental, cultural, flora, fauna and heritage matters.
- g) Gas, electricity, water, sewerage and other utilities may be located within State Road Reservations. No warranty is given as to the existence, location and condition of other utilities within the State Road Reservations. Prior to the commencement of works the permit holder must obtain all necessary approvals and information on the location of utilities from other utility owners having plant installed in the State Road Reservations that may be affected by the works. Permit holders should contact 'Dial Before You Dig' on 1100 or via <http://1100.com.au/default.aspx> to obtain this information. The permit holder will be responsible for any costs, claims, proceedings and any damages, should any other utilities be damaged as a result of its work.
- h) The permit holder will save and keep indemnified the Minister administering the *Roads and Jetties Act 1935*, against all or any costs, claims, proceedings and demands whatsoever and by whomsoever, arising out of or in respect of the works undertaken in the State Road Reservation.
- i) **Using the attached "Advice of Completion of Work" form the permit holder will notify the Department when all works have been completed.**
- j) This permit is current for **nine (9) months only** from the date of issue. A further permit is required if works are not completed within the period specified or if additional works are intended.

The Department's supervisors or contractors may conduct audits for your compliance with these requirements.

Please sign and return the attached permit agreement with an indicated date of commencement of the proposed works. **This permit shall be valid only upon receipt of the agreement**, and any queries regarding the conditions of the permit should be referred to the above Officer.

If for any reason during works the permit conditions cannot be adhered to, please contact the above Officer immediately as a permit variation may need to be issued.
