Introduction

Council currently supports community groups, private enterprise, not-for-profit and community events through in-kind support including staff time, financial contributions and waiving of fees on facility use and a variety of services. Consideration on what is currently being waived and the impact this will have on existing relationships needs to be considered.

Hall hire fees for 2018/19 that were adopted at the June Council meeting for 2018 note that not-for-profit and community groups can apply to have their hall hire fees waived. Regular users can apply for a 50% discount. Waiving of fees is in reality income forgone. It is not appear clear whether this waiver also applies to other in-kind costs that Council incurs.

The majority of our facility users are categorised in the list below. Waivers, in-kind support and hard costs are currently all factors which have resulted in a trend of high operating costs for Council facilities with minimal user pays income being generated. Council has understandably considered that this approach represents a low cost support mechanism for largely local residents, notwithstanding the difficult financial situation that Council faces.

Classification

Users are many and varied and, depending on the type of user, decisions on waiving or support may vary. Previous "community view" led to the situation where most community groups were grouped into the same category when, through experience, a more nuanced approach has evolved. Accordingly, as a guide, groups and users have been categorised broadly into the following classifications:

Community Event	Supporting community events is in line with Council's Strategic Plan. The in-kind and financial support enables the Community to deliver quality community events that contribute to our liveability and provide opportunities for economic and social benefit. Comments against each event provide a snapshot of the current financial and in-kind support provided to achieve this direction.
Community Group	Individual community members or groups where the aim is to deliver a community benefit through the use of the facility or where the group does not have enough financial resources.
Not-for-Profit Community Service	Community organisation that provides a community wide service e.g. Lions.
Not-for-Profit Business	Business that has not-for-profit status but operates as a business e.g. Flinders Island aboriginal Association Inc. (FIAAI), Duck Pond Child Care
Business	Private enterprise organisation.
Self Interest Group	Individual or community groups that meet to participate in an activity or event of personal interest.
Government	Government entity.
