# **Mayors Column**

#### Planning

At the July meeting Council as the planning authority approved the development of a house and outbuilding in the Rural Zone at Blue Rocks.

Council is trialing a change to its approval process in that: Councillors are advised of the discretionary development at the time it is advertised in The Examiner. If the proposed development does NOT attract a representation from the public or a request from Councillors within the regulated time frames then the application will be approval/or not without being presented to an Ordinary Meeting of Council. In the case of an approval the usual and specific conditions will be applied by the Planner. The aim of the change is to reduce cost and shorten approval time as the application will not need to be held over until it can be considered at a monthly Council Meeting.

#### Rates

Council agreed to an overall increase to the General Rate of 3.05%. The increase is the outcome of a 5.88% increase in the cents in the dollar on the assessed AAV of the land on all properties that attract above the minimum rate and a reduction of 6.0% to \$375 for the minimum rate.

Council has been required to reduce the minimum rate this year and last year due to legislation that requires a maximum of 35% of rateable properties be charged the minimum rate.

The Waste Levy on each title has been raised by \$17 to \$140 per property to support the ongoing upgrade of our waste management facilities.

The 2013-14 Fees and Charges were also approved and can be found on the Council Website. The Annual Plan for 2013-14 can also be found on the website. Council also agreed to allocate an additional \$17,000 to weed management that will include more trials on Parramatta Grass control and actions on other weeds.

Council also agreed to work with land owners to address the issue of the access to White Beach which currently is crossing over private land.

Also in the Lady Barron area, Council agreed to investigate the re-siting of the Lady Barron boat ramp that is currently in the Port area. Cr Willis will be seeking community input and discussion into the proposal.

# Guidelines are as follows:

# The following guidelines are to be used when consideration is given to Citizen Awards.

1. The awards will be given to persons who have made a significant contribution to the Furneaux region.

2. The nominees need not be residents of the Furneaux region.

3. The emphasis should be on voluntary contributions.

4. In all cases the contribution made should be for the benefit of the community.

5. A person can receive only one Citizen Award during his/her lifetime.

6. When reaching a decision the committee should give consideration to the quality of the contribution.

7. Nominated applicants should be over sixteen (16) years of age as at the first day of July in the year of the nomination.

8. No more than five awards will be given in any one year.

#### **Food Quality**

Did you know that food quality is also a Council issue? Any food products sold on the island are required to meet certain standards as set by the State (*Food Act 2003*) and Nationally under the Food Standards Code.

If a consumer feels that the product that they are purchasing does not meet their expectations they should report the issue to Council's Environmental Health Officer. Your details will remain anonymous to the retailer.

If you choose not to approach Council, speak to the retailer. Most are more than willing to replace or refund.

# Water

Council's EHO has recently received complaints or notifications of virus and disease that may be caused by drinking raw water. Please be vigilant with boiling raw drinking water for one minute prior to ingestion. It is good practice to keep a jug of boiled water in the fridge for drinking. Remember that although you may not be affected and are "used" to be water at home, the very young, the very old or those who don't normally drink raw water may not be as resilient to the amount of bacteria present in your water – and there will be some!

You are reminded that you are not to drink from the Whitemark water supply. If you are in need of water it is still available from Council's Patrick Street Depot.

#### Waste

Thank you to those residents who are taking the time to separate their glass and aluminium products. Please do not place general waste in the recycling bins. Anyone wishing to dispose of fluorescent tube lighting can bring the tubes in to the Council Offices for disposal.

# Dogs

Council is still experiencing incidents of dogs at large, particularly in the Whitemark area. Despite Council's recent enforcement efforts dogs are still creating issues within the public domain. An example is a dog that was recently roaming the streets which was nearly struck by a truck. This was distressing for the driver and witnesses as well as the obvious safety factors involved. It is the responsibility of local government to enforce the Dog Control Act in Tasmania. The continuous breaching of regulations by a small number of repeat offenders places Council in such a position that further enforcement of this Act may be the only option.
