Mayor's Column

February Council Meeting:

The 'Bushfire in Tasmania – A new approach to reducing our Statewide relative risk – July 2014 report put out by the State Fire Management Council was tabled at the meeting.

The report indicates that, tenure blind, Flinders has 5% of the treatable vegetation in Tasmania, i.e. vegetation suitable for control burning.

'The Furneaux Fire Management Area - Fire Protection Plan 2014-2019 (FPP) was also received at the meeting. The aim of the FPP is to document a coordinated and efficient identification approach towards and treatment of bush fire related risk to protect people, assets and other things valuable to the community. Projects are now being actively scoped to submit for The executive summary of the funding. report is on the council website as Annexure 16 in the February meeting agenda.

Ms Linda Nicol was approved as the Community Representative on the Aviation Special Committee.

A council sub-committee, the Ideas and Innovations Committee, was established as a group to which the Community can put forward their ideas and suggestions for projects and services in the Islands. The Committee consists of Cr Gerald Willis (Chair), Cr Chris Rhodes, Cr Peter Rhodes and Cr Ken Stockton.

The half yearly Budget Review at the 31st December was accepted as the budget for 2014-2015, with an amendment asking staff to look for a cheaper way to cool the hall, than the initial proposal that was developed to the guidelines of a grant that has been withdrawn. The "Uniform Policy"; "Travel & Accommodation Policy" and the 'Elected Members Allowances & Reimbursements Policy' were all accepted and are now open to Community comment for the next 28 days. Comments can be lodged at Council before the 19th March.

The Furneaux Group Waste Management Strategy 2014-2019 was adopted as part of a longer term strategy yet to be developed. The document outlines areas the Council is working on to improve the management of solid waste on the islands. The strategy is on the Council website.

Ten Days on the Island

The Bunk Puppets' shadow puppet performance called "Swamp Juice" is coming to Flinders Island on Friday 20th March as a part of the 2015 Tasmanian International Arts Festival.

This year, thanks to our local Regional Arts Branch, the Festival event will be coming to Flinders Island with no financial investment from Council.

SES

I was privileged to attend the presentation of service medals to the volunteer SES members last Saturday.

The Community is so much richer for having SES members committed to learning and training to cope with an emergency that is inevitable one day, but that we all hope will not happen. The Flinders Group is small but dedicated, practical and well equipped.

Enterprise Suitability Project

In October last year, as part of a joint Council/State project, data was collected from 10 temperature loggers at different locations around the west coast between Blue Rocks and Lughrata. Since then, the data has been modelled by DPIPWE to come up with some maps specific to 9 cropping scenarios.

DPIPWE looked at the growing conditions required for onions, carrot seed. blueberries, raspberries, sparkling wine grapes, table wine grapes, cherries, rye grass and barley and then considered the specific soil properties for the area and added the climate considerations derived from the logger data such as frost risk. Nine maps were then produced. These maps illustrate the extent to which each crop is suitable within the subject area; specifically, where the particular crop is well suited, suitable, marginally suitable or unsuitable.

There are a number of constraints that would need to be investigated at actual property level, for example wind and water supply, but these maps can provide a firstcut catchment level insight into what might grow and where. To access the maps, follow the instructions below:

- Enter 'the List 'into your search engine and Click on 'List Map'.
- On the top right hand corner, click on 'Add Layer'.
- Type in a search for 'enterprise maps' and click on the drop down box titled 'Primary Industries'.
- Click on 'Farming (21 layers)'. The resulting drop box will provide for all the crops investigated in Tasmania. Remembering the 9 crops that have been investigated for Flinders Island, add your crop of choice by clicking on the green dot with the white cross.
- When you return to the map, zoom in to Flinders Island and see the suitability for that crop.

Whitemark Foreshore Works

The Whitemark Foreshore amenity improvements, including the installation of permanent exercise equipment, will continue over the next months. A walking trail that meanders through the coastal vegetation between the new BBQ Shelter south to where the exercise equipment will be located has been cut and vegetation for pocket plantings will commence in autumn. The permanent exercise equipment was donated to the community from Tasmania Medicare Local's Healthy Islands Project (HIP) 2010 - 2013. Some vegetation on the foreshore has been removed to create space equipment. Local for the landscape designer, Sandy Downy, has designed a landscape plan for the foreshore that includes re-vegetation to the area. Civic Forecourt – Flinders Arts & Entertainment Centre (FAEC)

Manv would have recognised the transformation from the old gravel carpark at the front of the FAEC to a paved pedestrian only area with a solid masonry wall to protect the Rose Garden and a local stone feature wall. These works to the forecourt are close to completion. Timber slats across the wall, a water feature falling down the rock face and behind a bronze ANZAC Plaque will be installed in the coming weeks. The establishment of a 'civic centre' has been to create provision of an attractive outdoor area for events and community gatherings so to complement the entry to FAEC and to also provide a better visual amenity for the area. In addition, the new ANZAC memorial located within this development of the civic centre will create a focus area for ex-service men and women to be proud of during times of formal congregation and something to march to on ANZAC Day. A funding contribution from the Department of State Growth and also an ANZAC Centenary Local Grant has contributed to these works. Airport Road Safety Signage: Community Road Safety Partnership

Over the past year or so, Flinders Council staff and staff at the Department of State Growth (formally the Department of Infrastructure Energy & Resources) have worked alongside the Flinders Island Tourism Association and Tasmanian Police, particularly, Rowena Nicholls and Russell Judges, to deliver a road safety message that is unique to our Island that not only highlights the wildlife issue for drivers, but also the gravel roads that may cause problems to those who have never had to encounter either, or both at the same time.

The Community Road Safety Partnership (CRSP) project was funded and supported by the Tasmanian Government in accordance with priority road safety targets as identified through the Tasmanian Road Safety Strategy 2007- 2016 in conjunction with specific community needs.

The aim of the CRSP has been to increase awareness of road safety at a community level. The Project outcomes include, the use of the mirror hangs which will be placed in all hire cars on the Island, as well as a road safety sign, which has now been installed at the exit of the Whitemark Airport. The aim is that visitors to our Island will be made aware and conscious of the wildlife population that exists on Flinders Island and will drive accordingly on both sealed and unsealed roads. The sign and mirror hangs also makes note for all visitors to wave, as is the custom on Flinders Island.

Emita Hall

The upgrade works to the stage one of the refurbishment to the Emita Hall are very close to completion. These works commissioned to ensure that the hall will be weather and vermin proof and have included new cladding and internal linings.

The Emita Hall Committee has contributed to the funds required in this stage of the upgrade through their fundraising activities, particularly the Emita Sports held each January. Thank you to all Committee Members and thank you in advance for the painting of the interior, which will soon be ready to commence!

Lady Barron Hall Upgrades

In the approved 2014-2015 Council budget an allocation to the upgrade of the Lady Barron Hall was made by Council to primarily improve access to the hall, upgrade the toilet and kitchen facilities and install a disabled toilet. The Lady Barron Hall Committee led further community consultation around what community would like from the upgrade to sustain their current and future activities. A number o1. items were identified including a dedicated fitness space and a kitchen that could be used to not just heat food, but prepare it. This being the case, members from the Committee have drafted an application to the Tas Community Fund (TCF) that could fund this part of the upgrades. Thank you particularly to Fran Bryson and Judy Clark for drafting the TCF submission - and good luck with the application!

Development Services

A few issues have arisen lately regarding development (planning) and building (and plumbing) applications for new buildings, additions and minor structures etc. To assist those wishing to develop, some Frequently Asked Questions (FAQs) will be published in this and future Island News articles.. However always remember that if you are unsure, just ask!

FAQ:1

Who are the best people to use when preparing my development application?

That is a very tricky question and Council does not have a bias toward one or another. What Council can tell you is who is visiting the Island frequently or may be visiting soon. Feel free to call and make enquiries, it may save you considerable time and money.

FAQ:2

What is the difference between private certification and using Council as the Building Surveyor?

Again, this is your own choice and Council does not prefer one way or the other. There are some differences though.

For example:

Council is obliged to provide a Building Permit to the applicant, 14 days after all documentation has been submitted. A checklist is available if you wish to know what is required.

Council can perform inspections for footings and frame within 24 hours of a request and Occupancy and Completion inspections are carried out once per month by the Building and Plumbing inspectors.

If you are privately certified (you used another building surveyor, other than Council) you must arrange for that building surveyor to carry out all inspections.

- If you are privately certified you still gain a Building Permit from Council and also have state and local fees to pay.
- All plumbing and Special Plumbing works are still the responsibility of Council.

Development Applications of a discretionary nature are advertised in The Examiner on a Wednesday, in the notice board at the front door of the Council building, at the front counter within the Council building, on the Council website and also on the property.
