### **MAYOR'S COLUMN**

### **General Manager Recruitment:**

Council is in the process of settling a contract with its preferred applicant, with the aim that the new General Manager will begin in the position in January.

#### **Policies:**

At the October Council Meeting a Legal Advice Policy was approved for public comment for a period of 28 days. The policy outlines how the Council is to obtain and report on legal advice. If no submissions are received the policy will be adopted at the December meeting. The policy is open for comment until 1<sup>st</sup> December 2016.

# Development Application for Level 2 Quarry:

The submission period has closed. This is a proposal for a level 2 quarry as it is planned to produce more than 5,000 cubic metres of aggregate per annum. The Environment Protection Authority will now consider the submissions received in relation to the permit application and will provide Council with advice. Should the development be approved then conditions imposed by the EPA will be included in any permits issued for the operation of the quarry. Planning approval for the quarry expansion will be considered by Council in the near future, with advice from the consultant planners.

Councillors and relevant staff have visited both the quarry site and a neighbouring farm to see the site first and to hear the developer's plans and the neighbour's concerns.

The Planning Scheme is a legal document and Council can only consider the development application in respect to the contents of the Planning Scheme. If approved, Council has the ability to impose realistic conditions on the development.

#### **Badger Corner Boat Ramp:**

Council has several boat ramps around the Island that it owns and maintains. The question has been asked, if Council will acquire the crown land where the Badger Corner boat ramp is and make some improvements to the facility.

Councillors would be pleased to hear the views of users and people in the area regarding Council becoming involved in owning this facility.

#### **Davies Street parking:**

Council staff have taken the initiative to park on the grass area behind the Flinders Arts & Entertainment Centre to free up parking spaces for access to the library and child care. If parking on Davies Street for any length of time please leave the area near the "Duckpond" childcare facility free to assist parents to deliver and collect young children safely.

#### **Roadside Slashing:**

The annual roadside slashing program is underway. Please be considerate and slow down when passing the slasher.

The verges of the State Road have been completed with council roads now being worked on. Not all roads are slashed every year, with several of the minor roads being slashed less often.

#### **Save the Dates:**

The Furneaux Islands Festival, including the free Community Day of delicious food, entertainment and fun, is being held on the  $20^{th}$  -  $22^{nd}$  January 2017.
