### **Council Communications**

### **Lady Barron Waste Transfer Station**

### **Sharp Terminal Access at Launceston**

Following issues of vehicle access to the Sharp terminal at Launceston over the Christmas period when the car park was full, I am passing on the following message from the Launceston Airport General Manager: "... in a "car park full" situation, pressing the button on the console to page the duty operations officer will allow them to override the booms and grant access/egress to those wishing to perform Sharp pick-up or drop-off."

Please make use of this facility in a 'car park full' situation. Otherwise use the 8-minute leeway

given by taking a ticket to pick up and drop off passengers and/or freight.

### **Telecomms Communications Upgrade**

Work on the laying out of the fibre optic cable will begin in early 2018 with the path to be taken already having been mapped out.

### **Safe Harbour Project**

### **Current Opportunities to Make Comment**

#### **\*\*Airservices**

#### **(Submissions due 5/2/18)**

On 16 November 2017, the Senate moved that "The operation, regulation and funding of air route service delivery to rural, regional and remote communities" be referred to the Rural and Regional Affairs and Transport References Committee for inquiry and report. Particular reference is given to:

- (a) social and economic impacts of air route supply and airfare pricing;
- (b) different legal, regulatory, policy and pricing frameworks and practices across the Commonwealth, states and territories;
- (c) how airlines determine fare pricing;
- (d) the determination of airport charges for landing and security fees, aircraft type and customer demand;
- (e) pricing determination, subsidisation and equity of airfares;
- (f) determination of regulated routes and distribution of residents' fares across regulated routes;
- (g) airline competition within rural and regional routes;
- (h) consistency of aircraft supply and retrieval of passengers by airlines during aircraft maintenance and breakdown;
- (i) all related costs and charges imposed by the Civil Aviation Safety Authority; and
- (j) any related matters.

#### **\*\*Councillor Allowances Review (Submissions due 16/2/18)**

The Tasmanian Industrial Commission is undertaking a review of Councillor allowances and has released the Issues paper identifying the areas that need to be determined as outlined in the Terms of Reference, which are:

- (a) The statutory roles of the respective offices of mayor, deputy mayor and councillor;
- (b) The appropriateness of setting allowances by council type/size given the need to ensure good governance while balancing councils' financial sustainability and the interests of ratepayers;
- (c) Any significant changes to the role or functions of local government since the last review;
- (d) The method of indexing allowances each year;
- (e) Whether an additional allowance should be made available to councillors who undertake training in governance relevant to local government or who have recognised experience in governance

In accordance with Flinders Council's Code of Tender and Contracts, Council is seeking suitably qualified businesses for inclusion on a register to pre-qualify to supply Council with various goods and services that from time to time Council may require.

The types of services that Council may require include, but are not limited to, building services; maintenance, plant and labour hire; architectural and building design; engineering services; human resources consulting, financial management; as well as supplies of general goods and services that are normally applicable for a local government including culverts, bridge components, roadside hardware, emulsion, aggregates, vehicle and machinery parts, cleaning products, workshop supplies and workwear.
