Building Inspections

This is a friendly reminder that if you are undertaking any building work under a Certificate of Likely Compliance or Substantial Compliance, it states on your which inspections certificate mandatory. The inspections are mandatory

under the Building Act. If it states on your certificate that a footings inspection is mandatory and Flinders Council is your building surveyor, please ensure Council is notified at least 2 working days prior to building work proceeding so that an inspection can be organised by a qualified surveyor. If inspections are not completed correctly then completion certificates cannot be issued once building work has been completed.
