

## **MAYOR'S REPORT**

As we approach the Council elections we are in a "caretaker" mode, ensuring that the current council doesn't make any decisions that will create difficulty for our new members. But, of course, the show must go on and there have been several developments that are interesting.

The letter sent out to the Premier and ministers about the fin fish farm threat to our pristine waters has been acknowledged by a couple of ministers but, as yet, we have received no indication that any action will be taken. I understand that a couple of politicians will be coming over for the Show, so that will give us all an opportunity to speak our mind. After all we are a marginal seat!

Speed signs showing a 40kph limit have now been erected at the entrance to Palana. To limit road kill, Council is also going to investigate placing beware wildlife signs near Palana and other places on the Island. Community members have also expressed concern about the Black Swans at the entrance to Whitemark, so we are putting some appropriate signs there too.

An issue was raised by a concerned member of the Lady Barron community regarding a leak in the water supply. TasWater has confirmed that it is aware of it. They are sending a specialist over to look at it and there is no danger to the supply itself.

Biosecurity Tasmania has received funding for a 3 year feral pig control project on Flinders Island and a Steering Committee is being formed to oversee and guide the project. Council will be represented on that committee and regular updates will be provided to the community.

In case you haven't seen the recent General Manager's Safe Harbour update on Council's website, I should highlight that the revised \$3M grant application requirements were met after a substantial amount of additional work and costs.

That work was completed by Council in June 2021.

Since then, Council has maintained regular contact with the department handling the grant application to track progress. To date, Council has not been advised of the outcome of the grant application and has not received any grant money. The most recent advice is that the Labor Government has halted all previous Government funding commitments until they can be evaluated against an undeveloped policy regarding previous Government funding commitments. We will keep you informed of progress made.

"To The Tasmanian State Premier & Ministers

Dear Premier and Ministers Matters of Interest Flinders Island Aquaculture Meeting

On Monday evening, 29 August 2022, Flinders Council convened a public meeting to gauge community attitudes towards the proposed allocation of leases on the Furneaux Islands western coasts to the aquaculture industry for fin fish, shellfish and seaweed culture.

The meeting was informed that the west coast of the Furneaux Group has been identified as suitable for aquaculture.

According to government sources, leases which have been identified, mapped and now made available for fin fish aquaculture under the Furneaux Islands Marine Farming Development Plan include;

- Roydon Island;
- Bun Beetons Point;
- Tanners Bay;
- Prime Seal Island (2);
- South Arthur Bay;
- East Little Chalky Island:
- Dover Point;
- Vansittart Island West; and
- Deep Bay West.

Other leases cover shellfish and seaweed.

None of the leases are protected as 'no go areas.' Companies can swap leases elsewhere for them by simple agreement and licence. Potential leases cover around 1631.41 ha of seabed, restricting community use, with serious penalties for trespass, including the possibility of substantial fines and prison terms.

Over 110 of the approximately 920 islands' residents attended the meeting. The Mayor and Councillors, departmental officers, elected members and citizens participated in the information and action discussions. Residents' opinions were sought at the conclusion of the session and the following motion resolved "That the Furneaux group of islands does not support fin fish farming in our island waters, ever".

Will the Premier ensure that no aquaculture leases will be allocated in the Furneaux Group of Islands 'waterways, as did her/his predecessor in relation to the East Coast of Tasmania?

## **UPCOMING ELECTION**


Everyone on the State roll is automatically enrolled and required to vote at the upcoming local government elections. It is not compulsory for those on the General Manager's Roll to vote.

# **NWTAS for CLEAN OCEANS**

This group was formed in Stanley in 2021 when locals became aware of the planned expansion of Industrial Fin Fish farming into Bass Strait. Our aim is to inform North West Coast residents of this plan, to represent those who oppose it and to lobby Government in order to prevent it.

We are aligned with Neighbours of Fish Farming (NOFF), and Tasmanian Alliance for Marine Protection (TAMP).

I write today on behalf of NWTAS4CO, to congratulate you, the Flinders Island Council, for your recent Public meeting on this issue.

We congratulate and thank you and the residents of Flinders Island for your strong, united stand against Industrial Fin Fish Farming in the waters around your beautiful island, ie Bass Strait.
