

MAYOR'S REPORT

On Monday the 20th February 2022, the Legislative Council of Tasmania will visit our shores, and bring with them Premier Jeremy Rockliff and Deputy Premier Michael Ferguson. They are visiting with a number of groups and organisations whilst here and will hold a civic reception at the Flinders Arts and Entertainment Centre from 4:15pm until 5:30pm. Come along to meet your local representatives, have a chat, or ask a question.

It is always a great opportunity to share our islands, our ways, our wants and needs with those who drive the decision-making that impacts us..

Monday will also see the official opening of the Henderson Dam project. Another project hampered by the pandemic, it is great to see it finally completed.

There has been some chatter over the last few weeks about the Safe Harbour project. I'd like to clear up a few bits of misinformation floating around the community.

- Design plans have been viewed and discussed by Councillors on a number of occasions, including in the lead up to the submission of the grant application, and during the tender process for parts of the project. We are still investigating some funding opportunities, so the design may change.
- Council does not already have the money for the project. An election promise was made in March of 2019 by Steve Martin. Council then had to undertake considerable work to ensure we met the grant criteria. COVID-19 unfortunately

impacted on this and it wasn't until June of 2021 that we were able to submit the grant. Council was notified in October 2022 that our Community Development Grant had been approved (16 months after submission). Council is still in the process of finalising the deed for this grant.

- The project was not shovel-ready. Council has had to undertake further studies such as bathymetry, develop detailed plans, a business case etc. Council has already incurred costs of over \$128,000 on the project.
- 4. It was quickly evident that the original funding promise was not going to deliver the original safe harbour concept plan. The boat ramp, rock wall, and associated facilities were deemed the most critical and were deemed stage 1.

As and when more funding becomes available, Council will continue developing the site. There is always the potential for a private developer/operator to get involved.
