

**MAYOR'S REPORT** 

Work on the contents of the Time Capsule is continuing at pace, with Joanna Lang and her group of volunteers slowly sorting, cataloguing, and preserving the items. There are many items in varying condition and a lot to go through to try and save what is possible. Hopefully, in the nottoo-distant future, we will be able to start sharing some of the contents, so everyone can see what was hidden away all those years.

Council has been made aware that, unfortunately, our local Bendigo Bank Agency, along with those across the country, will be shut down by Bendigo Bank at the end of July this year. We are working with Kylie Clifford and Lyndon Nicholls to hopefully find a way to enable our community to have on-island access to banking services.

At a Special Council Meeting held on Monday 3rd April, Council voted to rescind a motion recently passed to make changes to the proposed Safe Harbour design. Unfortunately, the funding body did not feel the new design met the criteria of the grant. Council will revert to the original design by Rare and continue to advocate for further funding to complete the project.

The results of the recent Boating Survey have been published on the Council website and the Flinders Boating Special Committee will use these answers to make recommendations to Council as to how grant money received from the State Government should be spent. There were a lot of suggestions and comments especially around the Emita and Palana boat ramps. It was great to read about people's memories of using the facilities and how we might be able to better service those who use the ramps and surrounding areas owned by Council.

Council is looking to review its Strategic Plan 2021-2031 and Priority Projects. We will undertake some community engagement in the coming months to gauge whether our current Strategic Plan is still where our community wants to be heading, or if changes needed. This is something that will happen each time a new Council is sworn in, with smaller reviews taking place annually.

It is important that everyone has the chance to comment on these documents. I will update through this column, the Council website and our social media when and how you can be heard.
