



MAYOR'S REPORT

In my last report, I mentioned that unfortunately our local Bendigo Bank Agency will be closing in July. This is obviously, terrible news for our local community, and our businesses. On the 19th April, Kylie Clifford, Warren Groves and myself flew to a last minute meeting with Janie Finlay MP, and senior managers from Bendigo Bank to discuss the effects that the closure will have on our island. We were also joined by the owners of the Beaconsfield Bendigo Bank Agency, who represented a community with many similarities to ours.

The Bendigo Bank representatives listened to our concerns and agreed to evaluate the new information and options discussed during the meeting. They will provide that information to their executive for further consideration and will get back to us within 2 weeks. No promises, no guarantees.

Council is reviewing its Strategic Plan. We have a survey that we would love for everyone in our community to complete. It can be accessed through the Council website, or a paper copy is available from reception at Council. The Strategic Plan is a document that Council uses as part of its decision-making process, to ensure that our plans are in line with community wants and needs.

There are also questions in the survey about Priority Projects aka 'Councils Wish List'. We currently have the following as Priority Projects – do we still need these or are there other projects we should be considering?

- Modern solid waste management practices.
- Reconstruct and seal Palana Road. Transfer ownership to State Government.
- Provide funding for TasWater to establish a wastewater solution for Flinders Island.
- Relocate Council Depot from residential area within Whitemark.
- North East River - Provide a state of the art 'off grid' northern location for campers.

There has recently been some media around the Local Government Review Report. It looks like one of the potential recommendations will be that Councils are forced to “create entirely new council identities, with fresh elections as soon as possible...” During our discussions with the Review Board, Councillors made it quite clear how detrimental amalgamation would be to our community and our islands.

There will be further consultation over the coming months, but Council will continue the fight to oppose amalgamation of our Council.

<p>North-East Consultation Group Dorset, Break O' Day, Flinders, George Town, Glamorgan-Spring Bay</p>	<p>Place and representation</p> <p>The North-East corner of Tasmania is predominantly agricultural but with several significant green energy and eco-tourism ventures, notably the Musselroe Bay and Cape Portland wind farms, the Blue Derby mountain bike trails, and a range of coastal holiday/tourist towns. While the sparse populations and large areas of these LGAs mean that their commuting connections are not quite as strong as for urban regions, the data clearly show that they are more closely connected to each other than to any other council areas. This relative isolation and shared geography also link these areas into a broader community of interest. While resident movement and identity links are not as strong between Flinders Island and Cape Barren Island and the mainland parts of this region, the importance of Bridport as a freight and transit link means that they would nevertheless be valuable contributors to the North-East Tasmania consultation group.</p>
	<p>Future needs and priorities</p> <p>This region faces a range of economic and demographic difficulties as well as important emerging opportunities. Like many of the state's more rural areas, the first of these is population ageing and also population decline in some areas. All four council areas in this consultation grouping are ageing more quickly than the state average and growing more slowly. These issues pose clear but not insurmountable challenges to the region's economic sustainability. They are compounded in many places by workforce shortages and high service provision costs arising from the small and dispersed nature of the region's population.</p>
