Lately, we've been seeking feedback on significant matters that could impact our island, community, and way of life. For example, the Department of Natural Resources and Environment is considering changes to size, bag, boat, and daily limits of various scalefish species and calamari, affecting recreational, commercial, and charter fishers. We recently held a public meeting on this topic, and though attended by a small group, the input we received was truly valuable and multiple submissions have been submitted.

Additionally, we've been actively engaging the community regarding the potential effects of the Future of Local Government Reform. This reform could involve our Council being part of a new super-council alongside Georgetown, Dorset, Break O'Day, and Glamorgan Spring Bay Councils. We're keen to hear your thoughts on the proposed amalgamations. Your perspective is important, and it matters!

We understand that when implementing changes as significant as those mentioned above, it's important to involve and consult the Community. We genuinely want to understand your preferred methods of informing and engaging with you.

We also understand that everyone has their preferred communication channels, and Council strives to make information available through multiple avenues. We are committed to finding innovative ways to improve our

communication efforts, so have devised a "Communications & Feedback Survey" which I hope you will participate in.
