

# MAYOR'S REPORT

At the July Ordinary Council Meeting, Councillors adopted the **Draft 2021-2031 Strategic Plan – revised July 2023** and allowed it to lay on the table for inspection, consideration and comment until the 8<sup>th</sup> August. The review has involved engaging with the community through several means to ensure that we, as a Council, are heading in the right direction.

It is also an opportunity for newly elected Councillors to participate in the process and contribute their unique perspectives and ideas.

From the Strategic Plan, Councillors also reviewed our Priority Projects and made a few changes.

Our Priority Projects – essentially a wish list of projects that we are unable to fully fund ourselves, now includes:

- Implement an island-based, integrated, multi-faceted waste management solution.
- Reconstruct and seal the remainder of Palana Road then transfer ownership to the State Government extending the current state road to form the main transport backbone for Flinders Island.
- Scope with TasWater wastewater treatment for the whole of Flinders Island.
- Construct a veterinary clinic on Flinders Island.
- Upgrade the airport runways and associated infrastructure to Civil Aviation Safety Authority requirements and in line with the Long-Term Asset Management Plan.
- Develop long-term residential accommodation for rental and purchase.

 Advocate for the provision of reliable childcare and early childhood education facility and services.

The submission period for the Future of Local Government review has now closed, but there is still an opportunity to have your say, or restate your case.

There is a community session being held as part of the hearings process. On Monday, 14<sup>th</sup> August, 5:30pm, members from across the North-East Catchment are able to address the board directly (through Zoom).

We are not sure if there will be any further opportunities to take part after this session.
