## Mayor's Column

### **June Council Meeting Outcomes:**

*Planning:* Approved the Development Application for a house in the Rural Zone at Lot 2, Armstrong Avenue, Killiecrankie. Adopted the Corporate Credit Card and Debt Collection Policies. All Council's Policies can be found in the Policy Manual on the website.

*Audit Panel:* Approved the Audit Panel's Charter, Work Plan and Meeting Procedures.

### **Strategic Plan:**

The Draft Strategic Plan will be launched for public comment post Councillors' final discussion on the document at the workshop this week.

Community input into this document is important and I encourage you all to read it and provide comments back to Council to inform the final contents of the plan.

### **2015-16 Budget:**

The Budget and Annual Plan will be on the July Council Meeting Agenda.

Councillors have discussed the draft budget at workshops, and a part of the budgeting process is considering fees and charges. There are proposed increases to the fees to be applied to planning and building applications and permits to reduce the amount of cross subsidization of building and planning from other forms of Council income.

Illegal building works will attract the largest fee increase as it is proposed to introduce a penalty charge for permits that apply to illegal developments - that is \$500 per permit will be charged on top of the normal fees for those permits that are not in place before the build. **Planning your development and applying for permits prior to starting the build or development will save both you and the Council a lot of extra work and expense.**

A \$10 increase to \$30 for the registration of a non-sterilized dog that is not classified as a working dog is proposed. An increase of \$20 to \$120 is proposed for a dog classified as a dangerous dog. Other dog fees are proposed to remain unchanged.

Many of the other charges are proposed to remain unchanged or increase only by CPI.

The draft budget includes continuing capital improvements to Council Infrastructure. Operational expenditure has been constrained to more closely match actual income. The 2015-16 Annual Plan will outline the work plan for Council for the 2016 financial year and this will be considered at the July Council Meeting. There is a strong directive from the Auditor General that Councils must budget for an Underlying Operational Profit and the proposed budget brings Flinders Council much closer to this than in past years. The staff have worked hard to identify savings and find increased revenue streams, such as in private works which includes Council's work on the State Road. Securing grant funding for projects also assists in this area.

The Draft 2015-16 Budget and 2015-16 Annual Plan can be found as an attachment to the July 16<sup>th</sup> Council Meeting Agenda to be released on Friday the 10<sup>th</sup> July.

### **Lady Barron Hall:**

A huge congratulations to the team effort of the Lady Barron Hall Special Committee members in achieving a grant of \$160,000 for the fitness annex and kitchen development at the Hall. This funding compliments that budgeted by Council for upgrading the disability access, toilets and storage at the Hall. Many thanks to Fran Bryson and Judy Clark for applying their skills and time to the Tas Community Fund (TCF)

application and to the Board of the TCF for recognising the community need and support for this development.

## **Whitemark Boat Ramp:**

I congratulate Brian Barnewall and Jana Harper for the successful application to the Recreational Boating Fund 2015-16 for funds to upgrade the Whitemark boat ramp. Equivalent Council funding is in the capital budget and the project is to be completed by end of June 2016.

## **Health:**

The Strength2Strength Program was recently launched on Flinders. Sixteen participants have committed to the twelve week course which was funded through Tasmania Medicare Local and is being delivered by Kathleen and David. The 'Exersite' equipment on the Whitemark Foreshore is being used as a part of this program. It is anticipated that another session will be held later this year and will be promoted through the Flinders Island General Practice or by direct referral from Allied Health Professionals.

## **Cat Management:**

Following the State Government announcement that it will deliver Tasmania's first Cat Management Plan by the year's end, the first meeting of the Tasmanian Cat Management Reference Group was held on 19<sup>th</sup> June 2015. The Reference Group was established by the Minister for Primary Industries, Jeremy Rockliff and includes representatives from the Tasmanian Farmers and Graziers Association, RSPCA, Hobart Cat Centre, Australian Veterinary Association, Cat Association of Tasmania, Landcare Tasmania, Local Government Association of Tasmania, NRM North, Tasmanian Conservation Trust and the University of Tasmania. Biosecurity Tasmania will work with the new Cat Management Reference Group to develop the Plan. Regular updates will be posted on the Biosecurity Tasmania website.

## **Dogs:**

Council is still receiving complaints about unrestrained dogs and there has been more on social media.

The legislation states that a dog in a road related area, which includes footpaths and nature strips in the town, is under effective control **only** if the dog is secured and restrained by means of a lead not exceeding 2 metres long held by hand by a person of sufficient age.

On private property the dog needs to be retained **securely within the property**.

In other public areas the dog needs to be under your control if not on a leash.

Whilst your straying or wandering dog may not be of concern to you it is to others. **There have been many warnings printed in this column; do not be surprised if you cop a fine for NOT having you dog restrained in the appropriate manner as per the legislation.**
