



## NOTES FROM THE MAYOR

### THE ISLANDER WAY

The Islander Way Project is getting under way this week. The main aims of the project are:

- To enable interested community members to engage with the project leaders so that their values, wants and hopes for future tourism on the Islands are heard.
- To create a vision based on community hopes, values and wants for future tourism on the Islands.
- To co-design with leaders and community members a tourism system driven by community values, wants and hopes.
- To collaborate among the community to identify sub projects, including small businesses, that will support achievement of the vision.
- To provide skilled coaching for participating community groups so that their sub projects and business ideas may reach successful fruition.
- To find ways to monitor and assess project achievement.

### COMMUNITY ENGAGEMENT WILL TAKE SEVERAL FORMS

It is important that the project leaders hold as many different methods of engagement with the community as possible. These will include working with community groups, individuals, self-formed groups, surveys, an interactive web site and so on.

### THE COMMUNITY LAUNCH OF THE PROJECT IS ON OCTOBER 8TH

The launch will be held in the FAEC in Whitemark, beginning at 5.00 pm and going to around 7.00 pm. There will be an introduction to the Brand Story that led directly to the Islander Way Project. This will be followed by an

introduction to the Islander Way Project by Dr Dianne Dredge and her associate Sarah Lebski. This will include a focus on how the engagement will be facilitated. I believe the project will be an amazing opportunity for Islanders to create and manage a visitor economy that is community driven. There will be time for questions and then for informal conversations while enjoying nibbles and drinks.

### THIS PROJECT DEPENDS ON YOU!

This project is not about consultants arriving on the Island/s, talking with a few, then going off to write a report. It depends totally on how the community shares hopes, fears and values. Without that, it will not succeed. I have high hopes that this can be a great start to a community-driven visitor economy. It may also influence other key aspects of life in the unique place that we call home. **Please try to attend.** If you can't, there will be many ways of participating as we proceed. Dianne is currently on the Island for just over four weeks and Sarah will come and go from Launceston but will spend valuable time here.

### TALKING OF OTHER IMPORTANT ISSUES

The State Government formed PESRAC – the Premier's Economic and Social Recovery Advisory Council. This is a group to advise on the State economic and social recovery from Covid-19. One aspect of the PESRAC advice is that Local Government be reformed as discussed in the Final Report released March 2021.
